In September 2017, Amazing Place received a government grant from the Administration on Aging. Three new programs are a part of the grant. These are the Amazing Place Connection Project (APCP), Transition Expansion, and Caregiver Education Expansion. The APCP is a group of social workers that help designated churches identify people in their congregation at risk for dementia. Transition expansion is an extension of Family Services by providing services for a year after people leave Amazing Place. The Caregiver Education is a new program offered to caregivers. The grant was initially scheduled to go through August 2020. An extension has been received until December 2020.
