Participant Activities: A state licensed adult day center, Amazing Place is a state of the art wellness center designed for those with mild to moderate dementia. Research has shown that those with dementia benefit from structure, stimulation and socialization. We offer programs that include cognitive stimulation, creative and cultural arts, civic service, fitness, compensatory cognitive interventions, and spirituality. Our invigorating program adapts itself to the interests and individual strengths of the participants. We are open 7:30a.m. to 6:00p.m., Monday - Friday. We customize care plans for our individual participants and meet routinely to review their status.

4b (Code:) (Expenses \$ 165,604. including grants of \$) (Revenue \$ 325.) Family Services & Education: Support is provided to families, via support groups, counseling sessions, and educational programming throughout the year. Support groups meet monthly - one group in the morning and another group in the evening. We hold family educational socials, where we bring in a speaker and provide lunch afterwards. We offer two six week courses, using the Powerful Tools for Caregivers curriculum.

4c (Code:) (Expenses \$ 71,740. including grants of \$) (Revenue \$) Community and Church Education: Amazing Place educates the community on topics related to life with dementia and brain health. We presented lectures to various churches, hospitals, and other groups either on site at our facility, or at other sites, on topics related to aging, brain health and dementia, educating over 2,800 persons.
